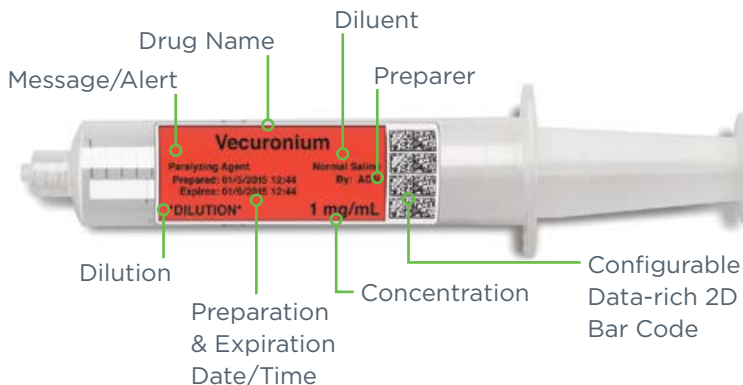

INTEGRATION CREATES LEANER WORKFLOW

Interoperability between the Anesthesia Workstation and Codonics Safe Label System saves steps for anesthesia providers—which is critical in high pressure OR environments.

Single Sign-On/Sign-Off — Login by biometric ID or other methods simultaneously provides access to the Anesthesia Workstation and Safe Label System. Logging off automatically restricts access to both systems.

Single Scan — After scanning a vial or ampoule on the Safe Label System, a label is printed and the medication information is sent to the Anesthesia Workstation, decrementing the inventory and capturing the appropriate patient charge. There is no need to scan the item twice.
